The Company may conduct the Contest concurrently and simultaneously on several participating radio stations owned and not owned by the Company, and in various States, and the Company may add or remove participating stations or change call letters of any participating station at any time during the Contest as announced on the affected station. Participating stations are listed above:

1. Description of Contest/Participation.

A. Dates of Contest: The Contest will begin on Monday, June 22, 2009 and end on or about Monday, August 31, 2009.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of entrants and the number of votes received.

B. How to enter:

Individuals 18 years or older and legal residents of Southern California must complete the following submission steps to be officially entered in the contest:

-Log on station website, kiisfm.com or 987fm.com, KEYWORD: CITYWALK.

-Each entrant must first play the interactive game and then will be prompted to fill out the online entry form. Once the online entry form is complete, the participant will be considered "entered" in the contest.

The deadline for all entries is 11:59PM on Monday, August 31, 2009.

By providing the entry elements described above, and officially entering this contest, individuals agree to: allow the Station to broadcast on-air and on-line all information provided for the purposes of promoting the contest, and accept and acknowledge the rules, regulations, restrictions and prize description "as is."

The Prize winners will be randomly selected and notified at the end on or about Tuesday, September 1, 2009.

2. Prize(s). The prize(s) that may be awarded to the eligible winner(s) are:

winner forfeits the prize and no other prize will be awarded in its place. If a winner cannot be contacted or is disqualified, The Company reserves the right to determine an alternate winner or to not award that winner's prize, in its sole discretion. All prizes must be accepted as awarded. The Company retains the right to substitute a prize with another similar prize of equal or greater value in the event the original prize offered is not available due to circumstances beyond The Company's control.
